Our General Requirements

Each year Victoria Teachers Credit Union receives a significant number of conference sponsorship requests.

We select sponsorship opportunities that are aligned with our strategic direction and corporate values. We will consider all proposals that provide benefit to the education community except those relating to single school events such as fetes, newsletters and sports days.

We generally require sponsorship exclusivity in the financial services area (*Banking, Insurance and Financial Planning*).

Our Guidelines

We consider conference sponsorships that provide a combination of the following benefits:

- Supportive of the education community.
- A natural link with our Corporate Values.
- The opportunity to present to the entire attendee group at an appropriate time early in the event program.
- Time for attendees to speak with a Credit Union Staff member.
- Opportunity for the Credit Union to set up a trade display.
- Naming rights to the event.
- Logo exposure and advertising in marketing materials (*including website*).
- Inclusion of Credit Union promotional materials in the attendee registration kit and/or attendee satchel.
